Project SDG NAVIGATOR - Empowering changemakers towards sustainability

UPDATE ON PROJECT RESULTS


After finalising the project's first output, the Sustainability Changemaker Competences Dictionary (SCCD), we are now getting closer to completing the other two foreseen outputs.

The Sustainability Navigator Learning Path (SNLP) consists of seven learning modules structured around seven sustainability-driven entrepreneurship stages and related processes, mobilising the competences in the SCCD. This tool leads individuals through the process of sustainability changemaking, helping them to apply their sustainability-oriented entrepreneurship competences throughout the different stages of sustainability-driven entrepreneurial action.

The seven stages/modules are based on a wellknown process-oriented framework on sustainability-driven entrepreneurship:

- 1. get ready
- 2. discovery
- 3. planning
- 4. start-up
- 5. build-out
- 6. consolidation
- 7. outreach

The SNLP has been completely translated and will soon be available, besides English, in the partnership's national languages on the project's website and platform, which you can access at www.sdgnavigator.eu/.



The SDG NAVIGATOR Digital Hub & Toolbox (SNDH) will integrate the SCCD and the SNLP to offer an interactive and personalised exploration of the available resources. It will also additionally include a thematic toolbox designed to support educators and consultants. Partners are now in the demanding process of translating all its contents into their languages.

Both the SNLP and the SNDH will soon be piloted in all the countries of the partnership, allowing to fine-tune these results and fully implement them.

THIRD TRANSNATIONAL PARTNER MEETING

The third Transnational Partner Meeting was hosted in Nicosia (Cyprus) by CARDET on 30 and 31 January 2024. It marked a significant milestone in the project's journey. Partners convened to discuss the finalisation of results 2 and 3, including the completion of the Process Path and the Sustainability Changemakers Competences Dictionary (SCCD).

FOURTH TRANSNATIONAL PARTNER MEETING

The fourth transnational meeting of the project took place virtually on 10 May 2024. The team charted the course for the project, finalising past achievements and setting a clear path forward. Key topics included management, quality control, impact assessment, communication strategies and the upcoming pilot phase.

The responsibility for hosting the meeting lied with Meta4, which invited MiMaMarkt, a Klagenfurt's communitybased supply chain, to present its sustainability practices to the partners.

MiMaMarkt is a unique, cooperatively owned centre that goes beyond shopping, offering a sustainable hub for the community. It consists of a supermarket stocked with regional, organic, and resource-conscious products, and an event room, cafe, donation centre, and more. MiMaMarkt embodies concepts like the circular economy and common good, promoting recycling, upcycling, and local businesses.



The project SDG NAVIGATOR is an Erasmus+ KA2 CP VET financed project. The project duration is 24 months, from 31.12.2022 to 30.12.2024 and will be implemented by partners from Lithuania, Portugal, Spain, Greece, Slovenia and Austria.
