## Capacity building



As the project partners continue their efforts of stakeholder engagement and awareness raising on combating workplace sexual harassment, a comprehensive package of eLearning modules for capacity building, that includes the legal frameworks of each country participating, has been created as open resource alongside the Guidelines and Seminar Curriculum already freely available through the project's [website](#).



The Guidelines, targeting HR professionals and managers, form a solid knowledge basis for people managers to know why they should care about sexual harassment and what to do to prevent and deal with it in the workplace.

The Capacity Building Seminar Curriculum, based on research findings, is intended for use by trainers working with HR managers and officers, team leaders, supervisors, senior staff members who coordinate teams from the public or private sector.

## Help Desks

To further help victims / survivors of workplace sexual harassment and employers who want to protect their employees from this phenomenon, one of **teamwork2**'s tangible outputs is the offer of local helplines. Each partner country has created a local Help Desk with dedicated professionals that can offer over the phone, free and anonymous legal advice to both employers/HR professionals and to employees falling victim to sexual harassment at work.
